ADVOCACY

2020 to Present ***Protect My Care***

Advocated for public health during the COVID-19 pandemic by participating in press conferences, writing press releases, speaking with media in person and in Zoom interviews, attending city council, school board and public health department meetings. Lobbied at the city and state level for mask mandates, vaccine outreach, expanded testing and other public health safety matters. Helped circulate a petition against the total abortion ban, signed by over 1,000 Tennessee doctors and healthcare workers and published as a full page ad in the Tennessean newspaper on Oct 9, 2022. Co-wrote a guest opinion column which was co-signed by over 400 Tennesseans, demanding action from state legislators on gun safety, published in the Tennessean newspaper on Aug 13, 2023. Currently advocating for gun safety legislation, reproductive healthcare access and expansion of Medicaid in Tennessee.

2019 to Present ***Gideon's Army***

Partnered with a local non-profit organization helping to reduce gun violence in Nashville, TN. Organized CPR and Stop the Bleed training for members. Lobbied Nashville metro council to increase awareness of gun violence and the importance of community violence interruption. Hosted a house party fundraiser in July 2019 and co-hosted another in August 2023, raising over \$9000. Serving on the board of directors since 2021.
