# **AMWA Supports Dr. Foster**

**D**espite an increased opposition to the nomination of Henry W. Foster, Jr., MD, as the next U.S. Surgeon General, AMWA has continued to express support for the nominee.

AMWA member Anne Colston Wentz, MD, obstetrician-gynecologist, joined eight of her medical colleagues to support Dr. Foster's nomination on February 10, 1995 at the National Press Club in Washington, DC. Following a brief statement by Dr. Foster at the beginning of the press conference, Dr. Wentz delivered a powerful message and was interviewed by several of the more than 30 journalists who attended the briefing.

"As an organization concerned about the quality of women's health care, AMWA applauds Dr. Foster's abilities for providing the full range of reproductive health services that comprise the routine and legal medical care of an obstetrician-gynecologist," said Dr. Wentz.

# Interim Meeting Highlights Managed Care

**M**anaged care and the role of medical students in AMWA are two highlights of the 1995 Interim Meeting to be held June 23-25 at The Washington Court Hotel in Washington, DC.

"With managed care increasingly becoming an important part of health care in America, AMWA believes that it is critical for our members to understand how it affects both women physicians and women's health issues," said Diana L. Dell, MD, FACOG, AMWA President.

The three-hour managed care seminar will be held Sunday morning followed by a guest speaker addressing women's health issues.

In addition to the managed care seminar, AMWA members will spend Saturday afternoon discussing the role of medical students in AMWA.

"This is a crucial issue for AMWA to address at this time," said Carolyn A. Webber, MD, AMWA's Director of Students. "We need to explore various ways to enhance

# AMWA's Women's Health Book Published

**T**o improve the consumer information on women's health issues The *Women's Complete Healthbook*, written by the American Medical Women's Association, will be available in June 1995.

Chosen as an offering by five book clubs, the 720-page publication is a comprehensive health book written by women professionals for women consumers. The five book clubs include Prevention, Psychotherapy, Book of the Month, Quality Paperback Club and Homestyle. Fiftyeight multi-specialty authors contributed to the 39 chapters which address critical women's health issues.

#### **Topics**

Being a savvy health care consumer is discussed in a section called "keeping yourself healthy." This section covers diet, nutrition, exercise, living and working in a healthy environment, overcoming chemical dependencies, mental health, stress, preventing violence against women, aging and sexuality.

#### PRESIDENT'S MESSAGE

## **Sweet Sorrow**

Diana L. Dell, MD, FACOG AMWA President



For the last few weeks I have been in active denial. But time has passed and I must really say goodbye to someone who has been very special to AMWA. And even more special to me.

My mind drifts back to 1990 when I attended my first AMWA Board of Directors meeting in Washington, DC. We talked a great deal about a strict new anti-

choice law being debated in the Louisiana legislature. The 1991 Annual Meeting was slated to be in New Orleans, and the Board of Directors was uncertain about meeting there.

There was one tall woman with black hair who had a name I could not pronounce. She seemed to know more about those events than I did, even though I lived and worked in Louisiana. She was intense and vitalized by this issue. Her fury and contempt for this legislative assault was contagious, and I caught her fire. During the next few weeks, she would also share her courage, her wealth of information about this issue and even some protective cautions.

In a very real way, Lois Schoenbrun literally changed the course of my life. I had written a paper about *Roe v. Wade* in 1973, but had never again found a channel for expressing my own feminist rage.

When I went back to Louisiana, I left the safe harbor of my busy practice and went to the committee rooms of the Louisiana Senate. During the next year's elections, I led a women's political group that supported women and prochoice candidates. And the following summer, worked on a steering committee that planned Baton Rouge's defense when Operation Rescue came to town. When I moved from Louisiana in 1993, a lot of that decision was about this issue.

During those years, Lois was my mentor. I must have talked with her a million times. I would come to know her as a vital and courageous women; I would learn about the time she spent as a clinic administrator; and hear how she felt when her office at the National Abortion Federation (NAF) was bombed. She has been my "source" — for information, encouragement, guidance and strength.

Some people come into our lives and leave indelible marks where they have been, so that we are never again the same as we were. Lois Schoenbrun has been such a person for me and for AMWA. I will miss her now, as our paths diverge. I wish her well, and sure footing on her own new course.

### AMWA Bids Farewell to Deputy Executive Director

Lois Schoenbrun resigned as AMWA's Deputy Executive Director and Director of Governmental Affairs effective March 24, 1995, after more than six years with the association.

Under Ms. Schoenbrun's leadership, AMWA has been a major presence in Washington, DC, with Congress, the Administration and the Executive Branch. Most recently, AMWA has been a significant player in health care reform.

In addition, Ms. Schoenbrun led efforts to have AMWA's voice heard on critical issues affecting women physicians and patients such as reproductive health, women in clinical trials and domestic violence.

Under Ms. Schoenbrun's direction, AMWA's sphere of influence was increased through its Legislative Network, a group of 600 AMWA members who can be mobilized to communicate with Congress on women's health issues.

In addition to these endeavors, Ms. Schoenbrun was responsible for financial and administrative matters, and had oversight for many of AMWA's women's health and physician education programs.

Ms. Schoenbrun leaves AMWA to become the Associate Executive Director for the Special Libraries Association, an international organization of librarians in government, private industry, medical facilities and other organizations with specialized information needs.

Her contributions to AMWA will be missed. We wish her well in her new position.

The reproductive health section covers genetics counseling, fertility, the reproductive system, pregnancy and sexually transmitted diseases.

In a broad section of The Women's Complete Healthbook, the symptoms, conditions, diseases, diagnoses and treatments are included in chapters focused on emergencies and traumas, the nervous system, eyes, breasts, respiratory system, the circulatory system, the endocrine system, the digestive system, the immune system and allergies, infectious diseases, and the urinary system. Other chapters in this section are devoted to the musculoskeletal system, skin, hair and nails, reconstructive and cosmetic surgery, cancer in women (prevention, symptoms, diagnosis and treatment), pain evaluation and managing medication.





# **Annual Meeting Topics Announced**

Culturally rich and scenically beautiful Seattle is the site for AMWA's 80th Annual Meeting to be held October 31 to November 5, 1995 at The Westin Hotel.

The theme for the meeting, Women Empowering Women: Planning Our Global Family, chosen by AMWA President, Diana L. Dell, MD, Assistant Professor, Department of Obstetrics-Gynecology at Duke University Medical Center, will highlight women's reproductive health issues.

National and international experts will discuss various elements of women's reproductive health care during the four-day conference.

This year, a special emphasis has been placed on career development issues and the annual meeting reflects this focus by including workshops on women's specialty organizations, how to recognize and change career paths, how to develop an individual career plan and the need to reform medical education materials.

In addition, the results of the AMWA/YWCA survey on gender equity in medicine will be released.

Combining career development

with the reproductive theme, the conference will offer an innovative workshop on how women physicians and medical students can explore their personal ethics regarding abortion.

AMWA's 80th Annual Meeting also showcases some of the association's grant projects with workshops on tobacco control, osteoporosis, coronary heart disease in women, and breast and cervical screening.

For medical students, AMWA offers seminars on choosing a special-ty/residency, maternity and medicine, the stresses of medical school and residency training, and the transition to residency.

Student sessions also include elections, branch development and orientation.

Other women's health topics include the U.S. testing and development of RU486, women and stroke, issues surrounding silicone breast implants, understanding obesity in women, death, dying and grieving, lesbian health issues, and AIDS and women.

Detailed information regarding the meeting and registration forms will be mailed in June.

#### GOVERNMENTAL

#### AFFAIRS

The Republican-controlled U.S. House of Representatives voted in January to abolish legislative service organizations, including the Congressional Caucus for Women's Issues.

The former committee staff has created a new organization called Women's Policy, Inc., to continue the Caucus services.

Women's Policy, Inc., will publish a weekly newsletter, a quarterly magazine, and special reports. Future plans include a fax bulletin service and on-line services.

But for Women's Policy, Inc., to operate, they must obtain support from private organizations and individuals.

In fact, the House Oversight Committee has ruled that congressional members are barred from subscribing to Women's Policy, Inc.'s publications until the group demonstrates that the majority of their support is from outside congressional offices.

This action defies both history and fairness — historically, members of Congress have enjoyed near total discretion to pay for subscriptions from their official allowances; and fairness — other service suppliers are not required to demonstrate that most of their support is from outside of congressional funds.

To compensate, Women's Policy, Inc., is seeking financial support.

The names of the first 50 "friends" who make contributions of \$1,000 will be released at a reception in late April. At the same time, the names of corporate "patrons" and foundation "benefactors" will be announced.

"Friends" also will receive a complimentary one-year subscription to the group's informational services.

## **Tobacco Project Update**

**M**oving forward with its tobacco grant project, AMWA has created a coalition of women and girls' organizations called *The Strategic Coalition of Women and Girls Against Tobacco*.

The Coalition will attempt to reduce the number of women and girls using tobacco products, thereby decreasing illness and death related to tobacco use. To accomplish this goal, the Coalition will launch consumer educational efforts and work with the media to raise the public awareness of this health threatening issue.

Coalition members also will work within their local and state communities to increase the public's knowledge of this issue. AMWA members are encouraged to join the Coalition. To request a packet of information, contact Liz Pejeau at AMWA.

# Enduring CME Program Under Development

To enable primary care physicians to be better equipped to provide care for their women patients, AMWA's Enduring Continuing Medical Education (CME) Program on Health Care for Mid-Life and Mature Women is being developed.

The program, funded by an unrestricted education grant from Bristol-Myers Squibb, is a stand-alone CME series developed from lectures at AMWA's Advanced Curriculum on Women's Health, Part I, held in October 1993 in New York.

AMWA's Enduring CME Program on Health Care for Mid-Life and Mature Women will be developed as a series of 12 modules which are delivered monthly. Each module in the series will include a 20-page illustrated manual containing transcribed and edited text of the original lecture plus all required CME testing and evaluation materials. Modules also

will include an audiotape of the lec-

Suggested topics include coronary heart disease, osteoporosis, hormone replacement therapy, breast and cervical cancer, mental health, menopause, substance abuse, smoking cessation, nutritional needs, fitness, and women and violence.

AMWA's Enduring CME Program is expected to be distributed to primary care physicians and ob-gyns practicing in pre-selected HMOs. The goal of the program is to reach 5,000 physicians in the initial pilot version. Following the anticipated success of the pilot program, the CME course is expected to be expanded.

# AMWA Co-Sponsors Tobacco Control Campaign

In conjunction with AMWA's Tobacco Control Project, the association is co-sponsoring INFACT's national challenge to tobacco industry leaders and congressional leaders to act responsibly for the public's good.

Similar to the goals of AMWA's Tobacco Control Project, INFACT's campaign is designed to draw attention to the fact that the tobacco industry markets their products to children and young adults, so that the public will demand that these targeted marketing efforts cease.

As part of this program, INFACT is asking sponsoring organizations to gather as many as 8,000 photographs depicting people who have died as a result of tobacco related illnesses, or currently suffering from a tobacco illness.

The photograph display, titled *Face the Faces*, will be used to challenge government leaders and tobacco industry lobbyists to ensure regulation of the industry; and to present to the leaders of Philip Morris and RJR Nabisco leaders at their Annual Shareholder Meetings.

As an AMWA member, here is how you can help further INFACT's

goals:

- •Send a photograph (black and white, color, any size) of a patient, friend or relative who has or has had a tobacco-related illness to Holly Segal at AMWA.
- •Ask your patients if they know of anyone who has died or is suffering from a tobacco related death to send a photograph to INFACT.
- •Post a sign in your waiting room, hospital or teaching facility informing your patients and colleagues about this project.

In addition to these efforts, Diana L. Dell, MD, FACOG, AMWA President, sent a letter to President Clinton in support of Dr. Foster. AMWA members also rallied support for the nomination by placing telephone calls to congressional representatives, particularly those Senators on the Labor and Human Resources Committee. (Note: Hearings have not been scheduled as of this writing.)
