### 1. Qualified Charitable Distributions (QCDs)

- Donate up to \$108,000 in 2025 directly from a Traditional IRA
- Reduces taxable income and may lower your AGI
- Counts toward your Required Minimum Distribution if age 73+
- Avoids capital gains and helps fulfill IRS RMD rules
- Must be a direct transfer from IRA custodian to AMWA

### 2. Charitable Remainder Trust (CRT)

Receive income during your lifetime. Leave a legacy to AMWA.

- Removes assets from your estate
- Defers capital gains on appreciated assets
- Provides a current-year tax deduction

#### Why Donate Securities?

Maximize Your Tax Benefit  
You may be able to deduct the full fair market value of the securities on the date AMWA receives them.

#### Avoid Capital Gains Tax

When you donate appreciated securities directly, you'll avoid paying capital gains you'd otherwise owe if you sold them.

#### Make Your Gift Go Further

As a 501(c)(3), AMWA can sell your donated securities tax-free, using 100% of your gift to support our Annual Campaign.

\*We recommend speaking with your tax professional before initiating a gift of securities. See IRS Publication 526 for details.

#### How to Make a Gift of Securities

1. Download the Stock Donation Letter to get started.

2. Contact your broker to verify their preferred delivery method (fax or original copy).

3. Complete, sign, and send the letter directly to your broker with the necessary transfer info.

Notify AMWA by email on the day of the transfer. Include the name of the stock and number of shares.

Note: If you delay notifying AMWA, your tax receipt may be delayed.

#### How Will AMWA Value My Securities?

Your gift is valued at the midpoint between the high and low prices of the stock on the date it is received in AMWA's account.


Transfers typically take a few days — but some may take longer, depending on your broker's process.

#### What Types of Securities Can Be Donated?

You may donate any securities that trade freely on NYSE, AMEX, or NASDAQ and are immediately sellable upon receipt. If you're unsure whether your securities are eligible, contact:

#### When Will I Get My Tax Receipt?

After AMWA receives your shares, we'll send a confirmation letter detailing your donation — which you can use for your tax records for the year in which the gift was received.
