For flight logistical reasons, I was not able to complete my scheduled visit to Vietnam last week, where the intention was to visit the Medical College and Hospital in Hue. Myanmar is also in the process of arranging a visit from a MWIA delegation later this year. There already exists in Myanmar an association of women doctors.

Brazil

The Association of Medical Women in Brazil has continued with scientific meetings; 14 April: Gender Differences in Cardiology Dr Elizabeth Alexandre (member of directory of ABMM and director of the new department of Feminine Cardiology of the Brazilian Society of Cardiology)

12 May: Osteoporosis/Osteopenia prevention and treatment Dr Marise L Castro,
Professor of Endocrinology

16 June: Medical Teaching and Training of Specialists, Dr Irene Abramovich,
coordinator of medical residency program of the São Paulo State Health Authority.

A forum on the Zika Virus will be held August 11th and will be entitled Myth and Truth.

Marilene Melo, VP of ABMM, received an invitation from the Academy of Medicine of São Paulo to write a chapter in “History of Women in Brazilian Medicine.” She is writing the chapter together with Dr Francys Patrício past president ABMM (2003-2008), director of ABMM.

Anna Maria Martits, endocrinologist, director of ABMM, was invited by the president of the scientific commission of the Brazilian Society of Endocrinology and Metabolism to the Congress in Costa do Sauípe, Bahia, September/16 to organize a workshop on gender medicine and endocrinology. This will be the first time gender has been on the agenda of an endocrinology meeting in Brazil.

Canada

The Federation of Medical Women of Canada has partnered with Cancer Care Ontario and the Canadian Cancer society.

The Federation was the first organization to have a Smear Campaign to promote Pap smears and over the years different partners have joined in. With this new partnership, it is possible to promote their Pap smear campaign, know as [**It's always better to catch things early.**](#)

Egypt

In response to a call from WHO to conduct consultations for the Accelerated Action for the Health of Adolescents, the Egyptian Medical Women entered an application to conduct interviews with young adolescents about their health. See more information under WHO.

Georgia

The Georgian Medical Women have founded the Health Professional Development and Support Fund (HDSF) for the Caucasian region and neighbouring countries. The ongoing project is the health professionals for the elimination and prevention of domestic and sexual violence against women and children. A short clinical manual on Domestic Violence for Health Professionals was developed in the Georgian language. It will also be translated into Russian and Azerbaijan. Training will also be organized for the education of health workers about sexual and domestic violence for the Caucasian region.

Sweden

The Medical Women's Association Sweden (KLF) was founded 1916 by Karolina Widerström. Karolina was the first female doctor in Sweden and graduated in 1888. She was very engaged and involved in questions concerning social justice and women's rights,

at a time when women's right to equal salary, to work and to vote was on the agenda. 2016 KLF celebrated its 100th Anniversary!

The celebrations were held April 23rd in the Swedish Medical Society house in Stockholm, Sweden. Around 150 doctors and medical students participated in a program with fantastic speakers, speaking about violence against women, gender equity for doctors, historical backgrounds through the last century, and barriers for women in the scientific world. The anniversary continued with mingling with champagne and then a big celebratory dinner with musicians and toasts in honour of KLF.

Switzerland

The topic of our annual conference in March 2015 was “Genetics today – from Mendel to personalized medicine”. The interesting meeting comprised the following presentations: “genome analysis”, “prenatal diagnosis”, “personalized medicine”, “genetic counseling” (legal foundations and consequences), and “biobanks.” As our guest, we were able to welcome MWIA President-elect, Bettina Pfleiderer, who talked about “Genetics – Possibilities without limits?”

In consideration of our difficult financial situation (stagnant number of members, rising administrative expenditure), fortunately we were able to accept generous first-time contributions from benefactors and sponsors (particularly hospitals).

Furthermore, we're trying to establish a professional mentoring program which shall respond to all requests comprehensively and swiftly.

Regarding contents and public appearance, we redesigned and published our guiding principles.

5. REPORT ON the meeting of the EXECUTIVE BOARD OF WHO

Dr. Shafika Nasser

The executive board of WHO met May 30-31, 2016, following the completion of the World Health Assembly. The executive board consists of 30 countries and NGOs are allowed as observers.

The technical and health matters discussed were dementia, improving access to assisted technology, prevention of deafness and hearing loss, health and climate change, international classification of disease, and use of mobile technology, known as m-health, for public health.

Prior to the executive board, during the World Health Assembly, Dr. Nasser was able to include comments from MWIA during the report on maternal, newborn and adolescent health and climate change and health.

6. REPORT FROM MWIA’S REPRESENTATIVES TO THE UN

Dr. Satty Gill Keswani and Dr. Padmini Murthy

Drs. Keswani and Murthy and Ms. Aishu Narasimhadevara have been closely following and attending the various UN meetings and have represented MWIA at the

events. In March 2016, Drs. Keswani and Murthy represented MWIA at the American Medical Women's Association's 101st annual meeting in Miami, Florida. In April, 2016, Dr. Murthy represented MWIA at the NGOCSW executive committee campaign to elect a woman Secretary General. Aishu Narasimhadevara has been representing MWIA as a member of the youth subcommittee for the 66th UN DPI NGO conference in Gyeongju, South Korea and participated in two panel discussions. In May, 2015, Dr. Murthy attended a work shop on Menstrual Hygiene to commemorate World Menstruation Day organized by International Rescue Committee.

MWIA is listed as a co-sponsor for the yoga day event which is being organized by the International Committee of Yoga in June, 2016. Dr. Murthy was an invited speaker representing MWIA at a symposium on "Health and the Environment: Science and Solutions" which was organized by the United Nations Academic Impact. Dr Murthy and Aishu Narasimhadevara represented MWIA at the high level AIDS meeting at the United Nations in June, 2016.

7. REPORT FROM MWIA'S REPRESENTATIVE TO WHO

Dr. Clarissa Fabre

The **World Health Assembly** in Geneva in May was, as usual, was an inspiring experience. I was there with Dr Shelley Ross, Dr Shafika Nasser and Dr Natalie Yap, a junior doctor from Australia.

We had a meeting with the new **Head of Maternal, Neonatal, Child and Adolescent Health** at the WHO, **Professor Anthony Costello**, and he discussed with us the main priorities facing the WHO at the moment. Top of these is the **Zika virus**, which is now in 60 countries and rising. There is now strong evidence of a link between maternal infection with the virus and microcephaly. Maternal infection with the virus has also been associated with severe brain damage, heart defects, stillbirth and neonatal deaths. As a consequence, the WHO has recently advised young women in Latin America and the Caribbean to avoid becoming pregnant during this epidemic, although these areas unfortunately have a very high incidence of unplanned pregnancies. Pregnant women returning from an affected area need an ultrasound scan, which should be repeated every 4 weeks for the rest of the pregnancy as the initial scan could be normal. The virus is known to be spread by mosquitoes, and it has been suggested that it might also be sexually transmitted. Men have been advised to use condoms while in an endemic area and for 4 weeks after their return (for the duration of the pregnancy if their wives are pregnant).

Professor Sir Michael Marmot is the current President of the World Medical Association and chaired a session on **Conflict and the Social Determinants of Health**. Youth unemployment is one of the causes and consequences of conflict, and is an urgent crisis globally. Conflict is a huge burden on women and has a major impact on the future psychological and physical well-being of children. It is important that education is available for children in conflict situations. We saw a very moving montage showing the effects of **attacks on health workers and health facilities** (see attached photo).

Every year we have a meeting with **Dr Claudia Garcia Moreno**, who is leading on **Violence against Women and Girls (VAWG)** at the WHO. She is lead author of the WHO **Clinical Handbook** on the subject, which has now been translated into Spanish, French and German. The WHO is developing a medical student curriculum and a training manual for practising doctors, as well as a parallel handbook for managers on how to organise a system for coping with VAWG, and how to finance it. Claudia was very interested in the online training module which MWIA has been developing over the last three years. She felt that MWIA could play a very useful role in disseminating the materials being developed by the WHO (www.who.int).

At one of the fringe events on **Women and Leadership**, we heard two women speak who were both outstanding. **Dr Margaret Mungherera** is a psychiatrist from Uganda and a former president of the World Medical Association. She set up **Hope after Rape** with 11 other women doctors in 1994 and was encouraged by Dr Shelley Ross at that time to form a women doctors' organisation in Uganda. At the fringe event, Shelley was specifically acknowledged, and spoke to everyone about MWIA and what our organisation is about. Dr Mungherera said that **universal primary education** has made a big difference in her country, but the challenge is *keeping* girls in school (early marriage and the 'bride price' are a problem). In some medical schools, women are excluded if they become pregnant, a practice which must stop. Dr Mungherera explained that it is important to work with leaders who are there in the community, to train, support and protect them. Role models are very important. In Uganda they have begun to look at boy children, and work with young men in order to change attitudes to women. Dr Mungherera said 'we would like to work with men as partners...Men can be part of the solution', a sentiment with which I entirely agree.

The second speaker was **Dr Bernice Dahn, a Minister for Health in Liberia**. With the Ebola outbreak there was a lot of fear and denial, and many health workers fled the country. Women began delivering their babies in the streets. Fortunately, the epidemic is under control, and the emphasis now is to prioritise the new **Sustainable Development Goals**.

8. REPORT FROM EUROPEAN WOMEN'S LOBBY

Dr. Edith Schratzberger

The exciting news from the European Women's Lobby is the election of MWIA's Dr. Edith Schratzberger as its new President. This should afford more opportunities for partnership between the two organizations.

9. REPORT FROM DPI/NGO CONFERENCE IN KOREA

a. Report from MWIA President, Kyung Ah Park

The 66th UN DPI/NGO Conference was held in Gyeongju, Korea and it was the first time this conference was held in East Asia.

The conference theme was "Education for Global Citizenship: Achieving the Sustainable Development Goals Together." This conference recognized that education holds the key

to achieving our common vision and a spirit of global citizenship will guide us on the path to peace and prosperity for all people in our planet.

There were four round tables with the themes of “The Right to Accessible, Safe and Inclusive Learning Spaces,” “STEAM Should Power the SDGs,” “Children and Youth,” and “Global Citizens as Stewards of the Planet.” Difficulties in the educational environment for the children and youth in many parts of the world were widely discussed such as the North Korean defectors in South Korea, human right issues in Myanmar and in Kenya, etc.

I would like to ask MWIA to take action on this issue starting with a new resolution for the next general assembly in Vienna.

The happiest event during the conference was to meet Aishu (Mini’s daughter) and talk with her. She was very actively participating in the program which is a wonderful opportunity for the young members of MWIA

b. Report on Youth Activities by Aishu Narasimhadevara

The United Nations 66th DPI/NGO conference was held in Gyeongju, South Korea, from 30 May-1 June 2016. The conference focused on Education for Global Citizenship, which incorporates the values of social responsibility and being a part of the global community.

Throughout the conference, there were many workshops, roundtable discussions, and interactive sessions where participants had the opportunity to share their viewpoints. The conference also included a youth platform that focused on youth participation through discussions and a youth hub, which was a space dedicated to meet other delegates with performances throughout the event. The youth caucuses in the conference incorporated the themes of Youth-led Innovation in Education, Formal Education in Conflict and Post-Conflict Situations, and Youth Employment/Underemployment, and Underemployment. Speakers whose work and expertise are related to themes shared their knowledge with delegates. The first caucus included Secretary-General Ban Ki-Moon who gave introductory remarks and mentioned the importance of youth. The input from caucuses was used to create a youth declaration highlighting the importance for Education for Global Citizenship. The document is to lay the foundation for involvement of youth in DPI/NGO related events. It was referenced in the Action Agenda, the conference outcome document.

Other youth-related activities included a dance on Day 2 of the conference where all the youth delegates danced to the song “Tell Everyone” by various African artists.

The DPI/NGO conference was a success and showcased the importance of Education in achieving the Sustainable Development Goals. The youth delegates were energetic and passionate about making a difference in society. I was honoured to represent MWIA as a youth delegate and was a speaker at the Intergenerational Panel and also was a

member of the youth sub group who met Under Secretary General of UN DPI, Cristina Gallach, for a one on one dialogue.
